The data collected may be transmitted by Taiwan Cooperative Bank, Hong Kong Branch to the Inland Revenue Department for transfer to the tax authority of another jurisdiction.

A person who commits the offence is liable on conviction to a fine at level 3 (i.e. \$10,000).
